






CONVENTION HOTEL MAP

TRANSLATION FROM ORIGINAL GREEK BY: RICHARD C. SEESTEDT, IR., COR 1986





You are admitted to the fellowship and privileges of The Alpha Delta Phi on condition of giving your assent to the articles of the following Covenant:

ARTICLE I. You do solemnly promise that you will perform promptly and faithfully all the laws and regulations enjoined by this Society, and, to the last extremity, you will support and defend what you conscientiously believe to be the spirit and intent of its Constitution.

ARTICLE II. You do solemnly promise that you will strive to cultivate in yourself a spirit of kindness, conciliation and good will towards every member of this Society, and that, whenever you may be reproved for a fault by any of your brethren, in that spirit prescribed by the Constitution, you will receive such reproof with gratitude, and that you will endeavor to profit by the same.

ARTICLE III. You do solemnly promise that in everything in which you shall stand related to this Society, you will guard strictly your conduct and thoughts; that on all occasions you will strive to cultivate an amiable temper, and kind, affable and cordial manners, together with everything that relates to your improvement as a social and moral being.

ARTICLE IV. You do solemnly promise that whenever any member of this Society shall ask of you a special and particular favor, provided only that such request be proper and lawful, you will use all proper and lawful means to oblige him; and further, that whenever you may meet a brother of this fraternity whether in or out of college, you will never fail to treat him with a particular and marked attention and respect.

ARTICLEV. You do solemnly promise that so long as you shall belong to the college of which you are now a member, you will set up for yourself a high standard of intellectual attainment; and that by a careful and diligent improvements of all your literary privileges, you will be faithful to yourself, and to the honor of this Society.

ARTICLEVI. You do solemnly promise that in that department of literature which has been or shall be assigned to you by the voice of this Society, it shall be the whole and sole object of your investigations to arrive at truth; and that you will not spare time, trouble, or research, and that you will do everything in your power to render your disquisitions elegant, pleasing, and instructive.



ARTICLEVII. You do solemnly promise that whenever you shall observe a fault in the character or conduct of any of your brethren which, in your opinion, may operate, directly or indirectly, to the injury of the individual or the interests of this Society, you will kindly and affectionately admonish him of the same.

ARTICLE VIII. You do solemnly promise that you will, under all circumstances and on all occasions, maintain the honor and interests of this Society, and that you will use all lawful means to safeguard its intellectual, moral, and social character, and to secure its permanent reputation and prosperity.

ARTICLE IX. You do solemnly promise that you will never, in any manner, either by word, look, or sign, or in any imaginable way, disclose or divulge, or cause to be disclosed or divulged, any of the acts, laws, designs, or its proceedings of this Society; and that you will do your utmost to draw a veil of perfect secrecy over all its concerns, until your connection with it shall be dissolved by death.

ARTICLE X. You do solemnly promise that with respect to every brother member of this Society, you will at all times and places, and under all circumstances, and on all occasions, do everything in your power to defend, support and maintain his moral and social character and his intellectual and literacy reputation; and that whenever he shall be unrighteously accused of malignantly slandered, you will repel the attack with an honest and manly indignation, and that whenever you may hear of false reports, which may operate to his injury, you will endeavor to prevent their further circulation in short in all things which pertain to his personal character, and his reputation with his associates and the world, you will espouse his cause as if it were your own, and that you will constantly exercise towards him a spirit of charity, kindness and fraternal love.





OFFICIAL RULES OF CONVENTION

- 1. Speakers should identify themselves by name, chapter, and class when recognized by the Presiding Officer and before addressing the Convention.
- 2. All brothers may be recognized by the Presiding Officer and can speak and make motions. The right to vote and second motions is restricted to accredited delegates.
- 3. All accredited delegates should sit near the front of the meeting room.
- 4. All members are expected to attend the Convention in appropriate dress. No alcohol may be consumed during the Convention Sessions or Leadership Training Conference. All business sessions are non-smoking.
- 5. The standing Convention Committees shall be:
 - Committee on Credentials
 - 2. Committee on Conventions
- 3. The Presiding Officer shall have the power to name other committees as he deems necessary for matters to be brought before the Convention and shall have the power of selecting the Chairman and members of any such committee required.
- 6. Each such committee appointed shall be prepared to report its deliberations at the Regular Convention Sessions.
- 7. No new business may be introduced at the Convention from the floor after the close of the Second Regular Session (Friday Afternoon).
- 8. Robert's Rules of Order shall be used as a parliamentary guide, except that all questions of procedure shall be resolved by the Parliamentarian of the Convention unless delegates, by two-thirds vote shall otherwise determine.
- 9. Where feasible, any delegate making a motion or proposing an amendment to a motion from the floor, shall present the Secretary of the Convention with a written copy of such motion or amendment at the time it is made.
- 10. Due to the pressure of time, debate may be cut off by a majority vote, unless the Presiding Officer rules it an important question where a two-thirds vote is required for closure.
- II. Delegates are expected to attend all Convention Sessions. If delegates leave the Convention early or do not attend Sessions, their Convention subsidies may be reduced proportionately by the Budget Committee of the Board of Governors.
- 12. Only members of the fraternity and invited guests of the Board of Governors will be allowed to attend the Regular Convention Sessions. Any individual may attend the Leadership Training Sessions, lunches, dinners, and/or banquets.
- 13. During Convention Sessions, electronic communication devices such as telephones or pagers may not be used, and must be set to an inaudible state.
- 14. The Secretary of the Convention shall tape record all business sessions of the Convention.
- 15. If a chapter or alumni organization specifies or registers a member brother for attendance at the annual convention and that individual fails to attend the convention in an unexcused manner that member's organization will be billed actual costs by the Alpha Delta Phi International for each individual with payment due by October 1st of that year.

William "Bill" E. Smith was the fifth general manager for the Minnesota Twins Baseball Club. Smith served as GM from 2007-2011, during which the team won its two most recent division titles. He is widely known for his management during the construction and renovation of its spring training facility in Fort Myers, FL. Most recently, Smith oversaw the development of a players' academy in the Dominican Republic that is shared with the Philadelphia Phillies. Smith retired from the Twins organization in 2016.

Smith attended Hamilton College and was initiated into the Hamilton Chapter. He currently lives in Bloomington, MN, with his wife and their three daughters.




ABOUT MINNEAPOLIS

ABOUT THE BOARD OF GOVERNORS

The Board of Governors is made up of twelve Alumni Governors, elected for a three year term, and three Student Governors, elected annually by the Convention. The terms of the Alumni Governors are staggered to provide continuity. There are other restrictions on who may be elected to assure that no region or chapter may dominate the Board. No more than two Alumni Governors from the same chapter can serve at one time.

The Board of Governors generally holds four regular meetings each year. One meeting is at the Convention; others are held at various locations in the fall, winter, and spring - usually in locations with active chapters or affiliates.

The Governors elect the President, Vice President, and Treasurer of the Fraternity from among themselves. The President, with the Board's approval, appoints the Secretary and Assistant Treasurer, who may or may not be Governors.

HISTORY OF THE MINNESOTA CHAPTER

In the spring of 1890, a movement was first made by a small group of students at the University to obtain a charter for a chapter of the Fraternity. They presented a petition at the next convention, which was referred to the Johns Hopkins Chapter to investigate and report, but little was done.

As a result, however, the local alumni residing in Minneapolis and Saint Paul, at the request of this group, took the matter up and made a thorough investigation of all the men who desired to become charter members. They selected five men who organized themselves as a local society under the name of Alpha Delta Epsilon for the purpose of holding together until a charter could be obtained. At this time William Watts Folwell, Geneva 1857, the first President of the University of Minnesota, became interested and it was largely through his sponsorship that the Minnesota Chapter was founded.

A petition was formulated and signed by leading alumni in the Northwest and presented for the consideration of the convention held in Baltimore during May 1891.

On November 24, 1891, the Executive Council ordered the charter to be issued. Five charter members were initiated at this time under the auspices of the local alumni of the Twin Cities on February 22, 1892. This chapter had also been endorsed by many of the alumni associations, including those of Omaha, Chicago, Buffalo, and Cleveland. Indeed, at the initiation, there were forty-three members present, representing sixteen different chapters.



Owing to the fact that most of the leading fraternities had been represented in the University for several years prior to the chapter's installation and had built up a strong local body of young alumni in the Twin Cities, extra effort was required to maintain the high standards of Alpha Delta Phi. However, by keeping it as its watchword "quality and not numbers", the chapter has been able to maintain its position on the campus.

The chapter has been fortunate in having its own chapter house during all but the earliest part of its history. In 1925, the old house was razed and the present structure was erected on the same ground opposite the campus. In 2015, the chapter founded the Star & Crescent Foundation which is committed to restoring the aging chapter house as well as other historic structures in the neighboring community.
